



City of Las Vegas Film Permit- Prior to filming at the Fremont Street Experience, you must obtain a film permit from the City of Las Vegas. The City of Las Vegas Film Office hours are Monday-Thursday from 7am-5:30pm. The Film Permit office is closed on Fridays. You also must satisfy the required certificates of Insurance (COI)

Filming Requirements- Prior to filming at the Fremont Street Experience, we must receive and approve:

Film Permit 1- Approved and Issued City of Las Vegas Film Permit

Approved Certificate of Insurance (COI)-Naming the City of Las Vegas Elected Officials, additionally naming Metropolitan Police Department as insured

Film Permit 2- Approved FSE Film Permit

Approved Certificate of Insurance (COI)- Naming Fremont Street Experience as additional insured

Signed and Approved: 2023 FSE Location Agreement

All required cost & billing: Must be approved and confirmed 3 days prior to production start

Nevada Film Registration Number is required

LIVE Entertainment-Live musical entertainment is scheduled daily on one or more of our three stages. Please keep this in mind when scheduling your filming dates. Bands cannot be filmed, and audio cannot be recorded from these performances without a written agreement from the Band/Touring Management and the FSE Filming & Concert Coordinator.

Audio Cutoff: There will be a fee to have any FSE mall audio cutoff during your filming.

Band Buyout: A band buyout would be required to have the audio from a "Live Band" silenced during your Film Shoot. Should you require set times and dates of the event please contact Abriana Buffolino at abuffolino@vegasexperience.com prior to your scheduled shoot.

Special Events- Booked and scheduled special events cannot be filmed or audio recorded without written consent from the party organizer. Please inquire prior to your production to make sure the dates(s) and/or times are available.

Blackout-NO FILM DATES- Please check with Abriana Buffolino at abuffolino@vegasexperience.com on blackout or no film days.

Viva Vision Light Show- Our canopy provides a Viva Vision (VV) light show several times nightly. The Viva Vision Shows start at the top of each hour, beginning at 6pm each evening. Each (VV) lightshow is approximately 10 minutes per show.

****** During the Viva Vision light show all Fremont Street exterior casino lights will go down and the lights show's music will play throughout the mall on the 550,000-watt sound system. Filming of the Viva Vision shows is prohibited without prior arrangement and written consent. Audio/media cannot be captured from our Viva Vision shows and produced for commercial purposes; we are not licensed to allow third party usage of any audio/media featured. If you are interested in using audio/media from the Viva Vision light shows, please obtain the licensing/ copy rights from each artist/rights holder for each song and send a copy to the FSE Film Coordinator for confirmation before use.

Parking- Vehicles may be parked in white zones with prior approval and zone permits from the City of Las Vegas. Zone permits must be on display in the vehicle windshield to avoid towing. Paid parking is also available in the Fremont Street Experience parking garage located on the corner of Carson St. & 4th Ave. Vehicles may also be parked in designated areas on the Fremont Street Experience mall with prior notice and pre-approval only. A \$200 fee per vehicle will apply. All vehicles parked on FSE Mall must have drip pans and wheel chucks.

Ziplines- Our zip line attraction, Slotzilla, has 2 zip lines in operation that launch from one tower between Fourth Street and Las Vegas Blvd. There are four static lines for each level and each level launches separately. The lower "Zip" line launches from 77 feet high and extends half the length of the canopy, approximately 850 feet. Guests fly in a traditional seated harness position. The upper "Zoom" line launches from 114 feet high and extends the entire length of the canopy, approx. 5 city blocks and 1,700 feet high. Riders are in the prone or "superman" position during flight. ****** Filming is not permitted on either static line without pre-approval from the FSE Film Coordinator and the Slotzilla ride engineers. Production companies will not be reimbursed for ticket purchases or time blocks if a filming member miss his or her flight. If filming on Slotzilla takes longer than approved time, additional fees will apply. Ride limitations are 60-300 pounds per person on the Zipline, 100-300 pounds on the Zoomline and a height restriction that cannot exceed 6 feet 8 inches for both.

Casino Filming- If you plan to film inside a casino, or film casino employees, you will need to contact the casino directly to obtain prior authorization. The City of Las Vegas/ Fremont Street Experience permit covers casino exteriors only.

Business Access- All casino, kiosk and shop entrances and exits must remain unobstructed at all times. Ample space must be given to maintain pedestrian access to businesses and emergency vehicle access. You will need to get pre-approval to film on the sidewalks in front of the resorts.

Date of Shoot- Please have all of your paperwork that you have completed with the city/county as well as Fremont Street Experience with you on the FSE mall the day of your production. If any of your information on the paperwork has been changed this must be reflected on your physical paperwork while on the mall. Film permits and COIs must be on the set while filming.
