



## Filming at Fremont Street Experience

Thank you for your interest in filming at the Fremont Street Experience (FSE)! To ensure a smooth production process, we've outlined the necessary steps, permits, and guidelines. Please review the following information carefully to meet all requirements and make your filming experience successful.

---

### Required Approvals

Before filming, Fremont Street Experience must receive and approve the following:

- **FSE Film Permit**, COI, and a signed **FSE Location Agreement**.
- **City of Las Vegas Film Permit** and COI.
- Nevada Film Registration Number

---

### City of Las Vegas Film Permit

Before filming, you must obtain a **City of Las Vegas Film Permit**:

A valid **Certificate of Insurance (COI)** is also required, naming the City of Las Vegas and Metropolitan Police Department as additional insured.

### SlotZilla Zipline Filming

SlotZilla offers two thrilling zipline experiences:

- **Zip Line:** Launches at 77 feet high, spans 850 feet, and uses a seated harness.
- **Zoom Line:** Launches at 114 feet high, spans 1,700 feet, and uses a prone “superman” harness.

### Filming Requirements:

- Pre-approval is required from the FSE Film Coordinator and SlotZilla engineers.

### Parking Guidelines

- **FSE Parking Garage:** Paid parking is available at the corner of Carson St. & 4th Ave.
  - **Mall Parking:** Vehicles may park on the FSE mall with prior approval. A fee per vehicle applies. Vehicles must include drip pans and wheel chocks to protect the mall surface.

## Casino Filming

Filming inside casinos or of casino employees requires direct authorization from the casino. The FSE permit only covers casino exteriors.

---

## Business and Pedestrian Access

Ensure that all entrances, exits, and walkways always remain unobstructed. Emergency vehicle access must also be maintained. Sidewalk filming in front of resorts requires pre-approval.

---

## Live Entertainment Restrictions

Live music performances occur daily on FSE stages. Recording audio or filming these performances requires written approval from band/tour management and the FSE Filming & Concert Coordinator.

- **Audio Cutoffs:** Subject to additional fees.
- **Band Buyouts:** Required to silence a live band's audio.

## Special Events & Blackout Dates

Special events require written approval for film or record. Please contact [filming@vegasexperience.com](mailto:filming@vegasexperience.com) to confirm your desired dates and check for blackout days when filming is not allowed.

## Viva Vision Light Show

The Viva Vision canopy hosts nightly light shows starting at 6:00 PM, with shows at the top of each hour lasting approximately 10 minutes.

- Filming or using audio/media from Viva Vision shows requires prior written consent and licensing agreements.

---

## On-Site Requirements

On the day of your shoot, ensure you have the following:

- Approved permits and COIs.
- Any updated paperwork reflecting production changes.

All documents must be accessible on set during production.
